# **Classification Communique #1**

### UCI Post Athlete Evaluation Period Day 2

Given Covid -19 restrictions in many countries we are grateful that we were able to form one panel at this competition.

All athletes were requested to submit a Medical Diagnostic from (MDF) and supporting documentation 4 weeks prior to the Classification Evaluation and Competition. This Medical Diagnostic documentation was used to support the presence of Eligibility Impairment and Underlying Health conditions of the athletes undergoing Classification Evaluation.

#### Notification

The results of Athlete Evaluation for each athlete was given to the athlete and their NF representative verbally and in writing at the time of classification. The Results were then posted on the wall outside of the classification office.

As indicated in the UCI Regulations, Athletes have been designated a code or Sport Class accordingly: C, OA, NE or CNC.

- **C** : Confirmed
- **OA** : is a tracking code used for athletes who need to be seen in during training and or the first appearance in the competition.
- **NE** : Not Eligible
- **CNC** : Classification Not complete.

All athletes with a tracking code of OA will be seen during first appearance and the results will be posted on the board with the race results.

MRR there were some athletes who requested and were granted a Medical Review Request.

The IPC tasked UCI to collect all MDF forms on all athletes. As a result there were some confirmed athletes who were asked to submit Medical Diagnostic forms to complete our files and were reviewed.
