- all reasonable steps must be taken to ensure that the Protest is resolved at the earliest opportunity.

If an Nation feels they would like to protest following details set down in **16.4.023 National Protest Procedure by completing the** appropriate forms, on the UCI website, and sending it to the Chief Classifier for the event through the UCI Classification Coordinator at classification@uci.ch. This must be done within 24 hours of the final posting of the results by the Chief Classifier.
